## If you are traveling:

From Northwest: Take I-696 east to John C. Lodge freeway (M-10) south. Exit onto Grand Blvd. and turn left onto Grand Blvd. Continue on Grand Blvd. past the John C. Lodge service drive. Turn right onto Cass Avenue. Continue on southbound Cass Avenue and turn right onto Palmer Street. You may park in either the parking structure on the right side (use the student/visitor entrance), or the parking lot in front of the Law School on your left side, just west of Cass Avenue on Palmer Street.

From the South: Take I-75 North to the Lodge (M-10) North to Warren Avenue/Forest Avenue exit. After exiting at Warren Avenue/Forest Avenue stay on the northbound John C. Lodge service drive and proceed to the intersection of Warren Avenue and John C. Lodge northbound service drive. Turn right onto Warren Avenue. Take Warren to Cass Avenue and turn left. Take Cass Avenue to Palmer and turn left. There is a parking structure on your right side, or a parking lot in front of the Law School on your left side, just west of Cass Avenue on Palmer Street.

From the East: Take I-94 West to Exit 215 C: M-1/Woodward Avenue/ Brush Street. This will take you onto the service drive; proceed past Brush Street and John R Road to Woodward Avenue. Continue on the service drive in the westbound direction, past Woodward Avenue. Turn left on Cass Avenue. Turn right at the next light (Palmer Street). There is a parking structure on your right side, or a parking lot in front of the Law School on your left side, just west of Cass Avenue on Palmer Street.

From the West: Take I-96 East to I-94 East. Take Woodward Avenue exit (Exit No. 215 C: M-1/Woodward Avenue). This will take you onto the service drive. Turn right onto John R Road. The second side street (unsignalized) is Palmer Street. Turn Right onto Palmer Street. Take Palmer Street past Woodward Avenue and cross Cass Avenue. There is a parking structure on your right side, or a parking lot in front of the Law School on your left side, just west of Cass Avenue on Palmer Street.

Visitor parking fee is \$3.25, deposit coin (quarters only) or dollar bills into the machine at the entrance gate.
