From the Southwest and Detroit Metro Airport:

Follow I-94 East to the northbound Southfield Freeway (M-39). Exit onto northbound M-10 (Northwestern Highway/Lodge Freeway). Proceed north and exit at Ten Mile Road/Evergreen Road. Take the Northwestern Highway Service Drive to Ten Mile Road. Turn left onto Ten Mile Road. The campus entrance is on the right.

From the West and Ann Arbor (via I-94 and M-14):

Follow I-94 East to eastbound M-14. Continue on M-14 to northbound I-275. Take I-275 North to I-696 East. Proceed east on I-696 to southbound M-10 (Northwestern Highway/Lodge Freeway). Exit at Ten Mile Road/Evergreen Road. Turn right onto Ten Mile Road. The campus entrance is on the right.

From the Northwest and Lansing (via I-96 and I-696):

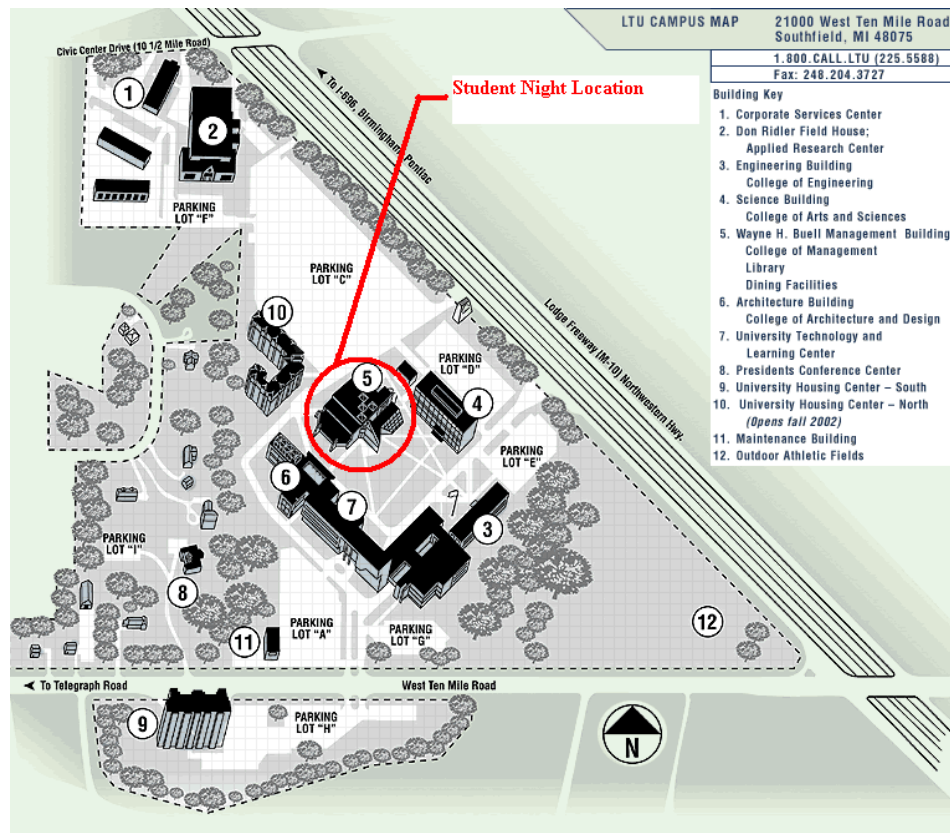

- The candidate civil engineer, to be eligible to receive this award, should be living at the time of his/her nomination and should be an active member of the Southeast Branch of the Michigan Section, American Society of Civil Engineers.
- A civil engineer who has moved out of state (or the country) may still be nominated for service during his/her residency in the Southeast Branch.
- Active members of the Board of Directors and/or the Award Committee shall not be eligible for the award.
- The candidate shall be 35 years of age or less as of the date of the Annual Meeting (May 2007)

- The project should demonstrate use of innovations in materials, technology or construction methods.
- Resourcefulness in planning and in the solution of design problems should be evident.
- The project should contribute to the well being of people and communities.
- Each project's potentially adverse effects on society and the environment should also be considered.
- Either the project or the headquarters of the prime design or construction firm must be located in Michigan.

Upper Rouge Tunnel Project Geotechnical Challenges

The proposed Upper Rouge Tunnel is a 30-foot diameter, 7-mile long rock tunnel. It is being designed to control 17 outfalls which currently discharge combined sewer overflow into the Upper Rouge River. The Detroit Water and Sewerage Department (DWSD), SOMAT Engineering, Inc., and Jacobs will present some of the geotechnical challenges associated with designing and constructing a tunnel of this magnitude through the southeastern Michigan bedrock.
